NOTICE OF HEARING ON VACATION OF PUBLIC WAY**

TO: Any Interested Parties

The Town Board has received a request for vacation of a portion of a public way. Under sec. 82.10(2), Wis. Stats., the Town Board may initiate proceedings to vacate a portion of a public way, and provide for a public hearing on the proposed discontinuance. The basis for John M. Halverson's request is to correct the road right away after the road was reconstructed.

John M. Halverson requests vacation of the part of John Wilkinson Road described as follows:

LEGAL DESCRIPTION OF PARCEL TO BE VACATED

A parcel Dane County Certified Survey Map No. 7052 recorded in Volume 35 of Certified Survey Maps on Pages 244 and 245 as Document Number 2447595, located in the NE $\frac{1}{4}$ -NW $\frac{1}{4}$ of Section 28, Town 8 North, Range 6 East, Town of Black Earth, Dane County, Wisconsin, described as follows:

Commencing at the North $\frac{1}{4}$ corner of said Section 28; thence S $00^{\circ}18'10''$ W, 890.19 feet along the East line of said NE $\frac{1}{4}$ -NW $\frac{1}{4}$ to a point on the Southerly r/w line of John Wilkinson Road; thence Southwesterly, 66.86 feet along the arc of a curve to the right having a central angle of $20^{\circ}55'58''$ and a radius of 183.00 feet, said arc also being the Southerly r/w line of John Wilkinson Road, the long chord of which bears S $45^{\circ}43'01''$ W, 66.49 feet to the point of beginning; thence S $56^{\circ}11'00''$ W, 173.82 feet along the Southerly r/w line of John Wilkinson Road; thence N $49^{\circ}37'32''$ E, 35.18 feet; thence N $55^{\circ}34'00''$ E, 33.11 feet; thence N $56^{\circ}11'00''$ E, 58.25 feet; thence N $61^{\circ}37'20''$ E, 46.07 feet; thence Northeasterly, 1.64 feet along the arc of a curve to the left having a central angle of $00^{\circ}30'54''$ and a radius of 183.00 feet, the long chord of which bears N $56^{\circ}26'27''$ E, 1.64 feet to the point of beginning, containing 0.01 acres, more or less.

There shall be a public hearing on the proposed vacation of the public way. The public hearing shall be held on April 9, 2013 at the Town of Black Earth Town Hall, 1116 Mills Street, Black Earth, WI 53515 at 6:00 p.m.
