- 2. Proof of Posting. An affidavit of posting was provided.
- 3. Approval of the Agenda. Don Ripp moved and Paul Wilichowski seconded a motion to approve the agenda. Motion carried. 7-0
- 4. Minutes of Previous Meeting September 20, 2022. Paul Wilichowski moved and Bruce Johnson seconded the motion to approve the minutes as presented. Motion carried. 7-0
- 5. Ross & Lacey Green, approx. 5230 John Wilkinson Rd driveway construction permit. Plan Commission members reviewed a proposed extension of a driveway to Lot 3, CSM 12467, parcel 0806-282-9440-0. Peter Weil moved and Bruce Johnson seconded the motion to recommend approval of Livestock Facilities Licensing Ordinance, Chapter 14 with the proposed amendments. Motion carried. 7-0.
- 7. Updating current Town Comprehensive Plan, Chapter 3-10 Land Use. No action was taken at this time.
