Minutes of Board of Review
Monday, June 1, 2026

1. Call Board of Review to order. Town Supervisor Barb Parrell called the 2026 Board of Review to order at 4:00 PM.
2. Roll Call. Supervisor Barb Parrell – present; Supervisor Joann Bennett – present; Alternate Dayna Dreis – present; Clerk Stephanie Zwettler – present; Assessor Bob Bachmann – present.
3. Confirmation of Board of Review notice. Clerk Stephanie Zwettler provided an affidavit of posting of the full Board of Review notice on May 12, 2026.
4. Select a Board Chairperson for BOR. Joann Bennett moved and Dayna Dreis seconded the motion to nominate Barb Parrell as Chairperson for the Board of Review. Motion carried. 3-0
5. Select a Vice-Chairperson for BOR. Select a Vice-Chairperson for Board of Review. Dayna Dreis moved and Barb Parrell seconded the motion to nominate Joann Bennett as Vice-Chairperson for the Board of Review. Motion carried. 3-0
6. Verify that at least one member has met the annual mandatory training requirements. Clerk Stephanie Zwettler provided the affidavit of the 2026 Board of Review training for Barb Parrell.
7. Review of new laws. Assessor Bob Bachmann reported recent law changes.
8. Adoption of amendment to policy regarding the procedure for sworn telephone testimony and sworn written testimony. The Clerk presented a policy regarding the procedure for sworn telephone and written testimony for approval.
9. Adoption of policy regarding the procedure for waiver of Board of Review hearing requests. The Clerk presented a policy regarding the procedure for waiver of Board of Review hearing requests for approval.
10. Assessment roll 2026. Assessor Bob Bachmann presented the 2026 assessment roll that was present at Open Book.
11. Assessor's Affidavit and Oath of Office. The Assessor's Affidavit and Oath of Office were signed and accepted by Clerk Stephanie Zwettler.
12. Review the assessment roll and perform statutory duties: examine the roll, correct description or calculation errors, add omitted property, and eliminate double-assessed property.
13. Certify all corrections of error under State law (Wis. Stat. 70.43)
14. Verify with the Assessor that open book changes are included in the assessment roll. Assessor Bob Bachmann confirmed that open book changes are included in the roll.

15. Objections, if any, to the assessment roll, and if proper notice/waivers given, unless scheduled for another date. The Clerk attested that there were no objections to this assessment roll, either verbal or written in the past 48 hours, which includes checking the post office box today prior to this Board of Review session.
16. Review Notices of Intent to File Objection. The Board of Review is now in session for the next 2 hours.
17. Adjourn. Joann Bennett moved and Dayna Dreis seconded the motion to adjourn the Board of Review Hearing.
